Minutes February meeting Wood County Amateur Radio Club February 11, 2008

Co-President Don, K8OVO, called the meeting to order at 7:35. The December minutes as published in CQ Chatter were approved. The Treasurer, WD8JWJ, reported a balance of \$1,973.41 on deposit. The Treasurer's report was approved.

Old Business:

Phil, W8PSK, reported that he had heard nothing as yet from K8ARL in Tiffin regarding IRLP (Internet Radio Linking Project) for our repeater.

Chuck, WD8ICP, asked if the \$40 per year charge for the post office box was worth the investment. After a short discussion, the consensus was that it was worthwhile and should be retained.

Repeater In Operation

As of the middle of February, the K8TIH repeaters are back in operation. Thanks to the fine effort of Jim, K8JU, the controller software has been reprogrammed and a new set of control codes installed. Provision has been made for any Club member to shut the machines down should the necessity arise. The autodial system is back in operation, along with speed dialing. Don, K8OVO, expressed the Club's thanks to Jim, Phil, W8PSK, and Chuck, WD8ICP, for their continuing efforts to keep the machines up and running. The one remaining item to take care of is the battery power alarm system on the receiver side, which would transmit an indication whenever the receivers are on battery power. ■

back in operation with ID and other control codes implemented. He passed around some information sheets listing the codes and describing the use of many of them. One significant change is that the control codes are being made available to all members of the Club. Jim also reviewed the codes and the macros that he has set up in the controller software.

Chuck, WD8ICP, reported on the joint meeting of the officers and Technical Committee to determine values of a number of control parameters, such as squelch tail duration, etc. The decision to have all members able to use control codes is especially important if the machine needs to be shut down due to misuse of some sort.

Jim added that when autopatching to police agencies (BGSU, BG City, Wood Co. Sheriff, Ohio State Highway Patrol are all local calls), be sure to identify yourself to the dispatcher and mention that it is simplex communication. To make a local call, simply dial the 7-digit number (no area codes necessary). He also stressed the need to keep these codes private among Club members to discourage miscreants.

Phil remarked that the battery power alarm is not yet installed.

Chuck asked if a listing of all the speed dial codes were available--not yet.

New Business:

Phil presented a formal request that Jim Davis, K8JU, be awarded a lifetime membership in WCARC. Phil cited Jim's expertise and hard work in maintaining and repairing the repeaters as a unique contribu-
