constitutional change to form a lifetime membership. Usually these are set at 20 times the annual membership dues. Duane mentioned that we need the access codes for the repeater controller. Bob Boughton had CDs with the controller information and gave one to Chuck and one to Duane. John has one too. The controller needs to have the time reset. As of the time of the meeting the repeater was not working. Chuck and Steve were planning to see what was wrong as soon as they left the meeting.

A class is being planned for license upgrade preparation. Please consult Duane if you are interested. The Sheriff's meeting room is the expected location for the class or classes. We will see what the interest is

and then set the class type to match.

A Boy Scout troop is interested in having a session for a radio merit badge in Tontogony. Don is also trying to get a list of scoutmasters in the area. A regional ARRL group is interested in sponsoring local proficiency tests for the code. You can get a certificate suitable for framing if you pass one of the tests.

Eric Willman expressed an interest in reviving digital radio in the area -- specifically connecting packet radio to Findlay and to the Internet. The technology would pass e-mail and perhaps images. The goal would be to be able to transfer this information from mobile stations in the field to locations out of the area in case of a emergency or for scheduled events. Steve would be interested in learning more. Speed would be limited to 9600 bytes per second. Another possible application would be to use GPS and APRS to allow the EMA to know where mobiles were deployed in an emergency. BGSU's Offenhauer Hall would be a possible interconnect site, with the connection going through the Club's PC there into the Internet. John thought we should have get this approved by the University since only certain kinds of traffic are being transferred now. Eric didn't think much Club money would be needed, just incidentals, but Club facilities would be used. The focus of the project would be emergency preparedness. Steve moved the project be approved, with Bob, N1RB, seconding. Motion approved.

Bill mentioned that ATV can be another valuable technology in an emergency. Don mentioned two nets people could check into for weather preparedness. He will send the specifics to N1RB for inclusion in CQ Chatter. Don said that there were

currently voids in Northwest Ohio where no one is able to deliver traffic from the major traffic nets. In an emergency this could be a particular problem.

Sheriff Mark Wasylyshyn, KD8BOI, popped in at this point and thanked those members of the club who had helped him plan changes to the county public service radio network. He expects the county to save \$9,000 yearly in phone line charges due to the new installation, which will pay off the system in about 10 years. asked the members their opinions about antenna location for officers' mobile radios. Eric mentioned that some antenna connectors used in this equipment can be problematic. This might vary model by model. Other considerations were mentioned by the members present, including the fact that antennas located near the waist might vary in efficiency in hitting the repeater depending on how the officer turns his body. Sometimes they are constrained from turning. Contact KD8BOI at wasyl@wcnet.org if you have further suggestions on this.

Eric asked about the data technology idea mentioned above. KD8BOI would be interested in e-mail in an extended disaster (several days, such as a flood) and would also be interested in checking a web site for mail in such situations.

WB8NQW mentioned that PC's needed to be updated soon in order to make the transition to daylight savings time in mid-March. The transition time has been changed.

Don resumed his remarks saying that recruiting is underway for traffic handlers to fill the above voids. Our Tuesday night net doesn't convey traffic very often. Skywarn training is scheduled for 3/21 at

St. Lukes hospital.

At 8:45, Bob, WB8NQW moved that we adjourn. Motion carried.

Following the meeting, there was a brief film presentation regarding an Antarctic DXpedition.

## Repeater News

As was reported in the minutes, the WCARC repeaters were out of commission at meeting time. Due to the diligence of Chuck, WD8ICP and Steve, K8BBK, the cause of the shut down was identified as the 40 A fuse in the power supply. Having had a replacement handy, Chuck and Steve quickly got the repeater back up. It has been operating smoothly ever since---hopefully the cause of the fuse failure was due to a fault in the fuse itself and not some other more serious problem.

Also, on Monday, February 19, 2007, the K8TIH APRS repeater was put back on the air after being out of commission for several months. Thanks to William "Hoot" Gibson, WB8VUL, who has donated a working Heathkit HW-2036 2 meter transceiver. The radio has been modified to connect to the Kantronics KPC-3 TNC and has been set up to work on 144.390 Mhz. The radio is located in Offenhauer West and is available to anyone using APRS packet software.
