ALLEGED UNLICENSED BROAD-CASTER FINED \$10000 BY THE FCC from AR Newsline

Federal Communications Commission has affirmed a \$10,000 fine issued against Steven A. Skalecki of Milwaukee, Wisconsin. This for allegedly operating an unlicensed broadcast station and failing to heed FCC warnings to take it off the air. The story goes back to March 25, 2006. That's when FCC agents observed a radio station broadcasting on 92.9 MHz and located that the station was operating from a single family residence in Milwaukee and that Skalecki lived there. The agents took field strength measurements and determined that the signals being broadcast exceeded the limits for operation under Part 15 of the Commission's Rules and therefore required a license. An agent searched Commission databases and found no evidence of a Commission authorization for this operation on 92.9 MHz in Milwaukee, Wisconsin. Later that day, the agents knocked on the front door but there was no response. Before leaving they wrote up a Notice of Unauthorized Operation and left it between the inner and outer doors. It directed Skalecki to terminate operation of the unlicensed station immediately. As a follow-up the FCC sent a registered letter to Skalecki with the same demand. The return receipt from the U.S. Postal Service shows that Skalecki signed for and received the notice on April 24, 2006. Then on May 6th Commission agents again traced the broadcasts on 92.9 MHz to Skalecki's residence. They again tried to talk with those in the home but received no response. On May 10th the Chicago office received a response to the Notice of Unauthorized Operation issued to Skalecki. In it he denied having any broadcast equipment and also stated that no local broadcasts can be heard on 92.9 MHz.

Skalecki also acknowledged receipt of the notice left in the front storm door by Commission Agents on March 25th.

On March 1st, 14th, 24th as well as May 28th of 2007 Commission agents again traced the broadcasts on 92.9 MHz to Skalecki's home. On December 14, 2007, the Chicago Field Office issued a Notice of Apparent Liability for Forfeiture to Skalecki in the amount of \$10,000 for operating radio transmitting equipment on the frequency 92.9 MHz without a license. In his response to the proposed fine Skalecki again denied operating an unlicensed station. He did admit that he operated a weather monitoring station from that property, but claimed that the unlicensed broadcast station was operating from another nearby residence on which several antennas are located. On March 13th, the FCC rendered its decision on Skalecki response. It said that it would not cancel the proposed forfeiture based on Skalecki's claim that he was not operating an unlicensed broadcast station from his home. It said that only evidence Skalecki provided in support of his claim is a list of nine dates on which he states he observed a station operating on 92.9 MHz from a nearby residence but the FCC countered that it had determined the signals were coming from Skalecki home on those dates. The FCC also rejected Skalecki's claim that it could not assess a forfeiture because agents were unable to conduct an inspection. The FCC says that whether or not agents were able to inspect the station does not affect its determination here that Skalecki violated Section 301 of the Act based on the direction finding evidence collected by its agents. It said that even if he did not personally operate the station that Skalecki is responsible for its unlicensed operation because he provided the facilities used in its operation. As such, he is required to pay the fine.
