has mounted his antenna atop his tower at about 60 feet, but so far has not had success with making connections. He asked if anyone who had a portable AREDN rig would be willing to set up at various spots around town, starting near to Phil's QTH in order to check it out. (FH) volunteered, and an attempt will be made on Aug. 9th. Tom (TOM) reported that he attended the Lucas County group's last meeting, and that Crissy (KC8UFV) of the Lucas County AREDN group has offered to help us out if needed.

- Bob (NQW) reported on a conversation he had with Steve (W8MSW) who works for the City, and who offered to let us set up an AREDN node on top of the city water tower at the corner of Newton and Brim Rds. Further discussion was made about considering building a local mesh network (est. cost ~\$200) and setting it up with a node at the water tower or perhaps the Courthouse Clock Tower. Suggestion was made to invite Crissy down to bounce ideas around.
- Eric (LEI) suggested the Clock Tower and mentioned that it should be no problem for him to gain access. Discussion followed about exactly where and how to mount the AREDN antennas.

- Motion was made and seconded (NQW/FH) for Eric to make contact with Jeff Klein (County EMA Director) to seek approval for the Club to mount a node on the Clock Tower. Motion passed unanimously. One idea is that Eric could mount his Ubiquiti antenna for testing and if it pans out, the Club could reimburse him to buy a replacement.
- Next, Eric (LEI) gave a brief report on recent Wood County ARES activities. He emphasized the excellent cooperation between the Club and ARES and with the County EMA as well. Eric also mentioned that he will be swapping out some 12 V-9 Ah lead cell batteries from the Sheriff's Dept. and will make them available at 5 for \$20 as before. The Sheriff's Office also participated in a "ham radio day" event with Robinson Elementary School but communications broke down and so video back up was used.
- At the last business meeting, an Ad Hoc Club Equipment Committee (NQW, FH, QGV) was set up to inventory all of the "stuff" that the Club owns. Bob (NQW) presented a slide show with about 25 images showing what we have. Some of it may fetch a good price on e-bay, other items are of historical value and should be kept in a safe place, and another group should be disposed of. Heath equipment still retains good value,

rewritten in English (not simply translated) so that new hams may grasp its operating concepts clearly.

eligibility

New hams who have just obtained their first license from the FCC may apply for a welcome package. Applicants must apply

within 30 days of the license grant date per the FCC records. The eligible ham must have a QRZ user account and be able to log in and apply for the award. Certain types of identification, including a photo ID, will be required. This information is not shared or exchanged continued on p. 8

to an ARISS press release Sergey Samburov, RV3DR, was the team lead coordinating with mission control to get the service module radio ready for APRS. Voice repeater transmissions are being made with a JVC Kenwood D710GA in the Columbus module. The same model radio is being used for APRS packet operation in the service module. Packet operations are on 145.825 MHz.

The call sign in the Columbus Module is NA1SS. The Service Module radio is using RSØISS. Both radios will be operating full-time except when ARISS is making contacts with schools, or during dockings, undockings and EVAs.

ARISS Operates on Voice Repeater and APRS at Same Time

from ARNewsline

There is a bit of celebration going on inside the International Space Station, where the ARISS Voice Repeater and digital APRS communications are now operating simultaneously. It is a big development.

It has taken the ARISS teams from Russia and the US several weeks of collaboration to prepare the Service Module radio for APRS operations, but APRS packet operation is now happening at the same time as transmissions on the space station's voice repeater. According


